I, **Ashley John Tiplady**, of Level 23, 66 Eagle Street, in the State of Queensland, Solicitor, state on oath:

- I am a solicitor and Partner of Mills Oakley and have the overall conduct of this proceeding on behalf of the Applicant. I am assisted in its day to day running by Andrew Greenhalgh, an admitted solicitor and Associate in my team.
- I was admitted to practise as a solicitor of the Supreme Court of Queensland in March 2002. Since that date I have practised exclusively in the areas of commercial litigation and insolvency.
- 3. Across the last 20 years I have had carriage of complex and multi-party litigation in various Australian State Supreme and District Courts, State Courts of Appeal, the Federal Court of Australia, the Full Court of the Federal Court of Australia, and the High Court of Australia. I have also had carriage of significant and complex litigation in the United Kingdom, continental Europe, New Zealand, the United States of America and the Caribbean. The conduct of such litigation has involved numerous costs assessments in respect of interlocutory hearings, trials and appeals. Relevantly, I have acted for the moving party in a number of court proceedings where there has been a very large number of respondents which has necessitated substituted service orders being sought from the relevant court.
- 4. I make this affidavit in support of the interlocutory relief sought by the Applicant being an application for substituted service orders.
- 5. I am familiar with Supreme Court proceeding 13638 of 2021 ("**Previous Proceeding**"), having taken detailed instructions from my client Mr

- Geoffrey Graeme Heaton, on that proceeding, and having reviewed the majority of the Court documents filed in that proceeding.
- 6. Part of the genesis of this proceeding is to effect the stated desire of members of Voyager Resort Ltd ACN 101 547 618 ("Voyager"), who passed a number of Resolutions at an extraordinary general meeting of members held on 13 November 2021 ("EGM"), including that Voyager be wound up (in circumstances where the purpose of the company having been incorporated has come to an end).

7. Such Resolutions included:

- (a) Amending Voyager's Articles of Association to allow service of notices, Court documents, instruments and / or other documents, by the Club, to any member, including by email and physical post;
- (b) That the voyager resort (which was operated as a timeshare scheme), located at 167 Old Burleigh Road, Broadbeach in the State of Queensland ("Resort") be sold;
- (c) That Voyager apply to the Supreme Court of Queensland for appointment of three of its directors as statutory trustees to sell the land on which the Resort operates, on certain conditions;
- (d) That the net sale proceeds of the Resort be determined and distributed to Voyager's members (in their capacity as timeshare owners and as members of Voyager) according to a defined formula;
- (e) That the net income of each lot forming the timeshare scheme, after payment of various costs and outgoings, be paid to Voyager; and
- (f) Upon completion of certain steps, Voyager be wound up, with Mr Bradley Hellen and Mr Nigel Markey of Pilot Partners appointed as liquidators of that company.
- 8. Exhibited hereto and marked "AJT-1" is a true copy of the minutes of the EGM, which were provided to me by Mr Heaton.
- 9. I seek leave to refer to an affidavit of Mr Benjamin Leigh Sanford of Mahoneys, affirmed on 8 December 2021 and filed in the Previous Proceeding. Exhibited hereto and marked "AJT-2" is a true copy of that affidavit. This affidavit discusses the impracticality of attending to personal service of the Respondents in the Previous Proceeding being, in effect, the same Respondents in this proceeding. I agree with what Mr Sanford says in paragraphs 3 to 41 of his affidavit.
- 10. I am informed by Mr Heaton and verily believe that there are in excess of 1,000 shareholders in Voyager. There is 1,067 Respondents to this Proceeding, being all identified shareholders in Voyager and other interested parties. To personally serve over 1,000 respondents, from past experience in matters involving a similar number of Respondents, would involve considerable work, I estimate that the cost of such personal service would be well in excess of \$100,000, including the costs for a paralegal (charging at \$200 per hour) to draft the covering letter to each Respondent, print the Court documents, instruct and co-ordinate a process server, the associated costs of the process server and subsequently preparing affidavits of service.

- 11. Further, as it would seem that a number of the Voyager shareholders are not located in Australia, and having further regard to the affidavit of Mr Sanford filed in the Previous Proceeding, I also anticipate that effecting timely and cost effective personal service on those shareholders located overseas will be difficult, if not impossible.
- 12. In circumstances where:
 - (a) I am informed by Mr Heaton and verily believe that he has currently active email addresses for in excess of 75% of the shareholders in Voyager; and
 - (b) The substituted service process that my client proposes was (largely) entered into in the Previous Proceeding and appeared to work effectively (save for approximately 12 of Respondents not being able to be contacted), though noting that the Resort land has since been sold in December 2022, such that there is no utility in posting the relevant Court documents on the notice board in the Resort's lobby,

I am of the view that the substituted service regime proposed in this interlocutory application will bring this proceeding to the attention of a significant number of Voyager's shareholders (likely to be in excess of 75% of those persons).

- 13. To otherwise require personal service upon each respondent to this proceeding would see significant costs incurred and cause significant delay, disproportionate to the work that remains outstanding in relation to finalising the winding up of Voyager.
- 14. If substituted service is granted, the intended notice to parties, which is to serve as a brief explanatory statement is exhibited hereto and marked "AJT-3".
- 15. Exhibited hereto and marked "AJT-4" is a copy of an email from Mr Peter Firkins to Mr Heaton dated 17 March 2023, that was provided to me by Mr Heaton. In this email Mr Firkins has agreed with substantially the form of the proposed substituted service orders sought on the Mills Oakley application (there having been subsequent changes to the draft reviewed by Mr Friskin in terms of dealing with the Explanatory Statement and consistent wording).
- 16. All the facts and circumstances deposed to in this affidavit are within my own knowledge save such as are deposed to from information only and my means of knowledge and sources of information appear on the face of this my Affidavit.

- The Trustees shall not be entitled to any remuneration (for the avoidance of doubt, their indemnity for properly incurred expenses remains).

Second, by the Share for Lots 1 and 2 being disbursed to the Club.

Third, by the Trustees retaining the net sale proceeds and dividing each remaining Share into fifty-one shares (the **Co-Owner Shares**).

Fourth, where the Fractional Interest held by the Co-Owner was not subject to a registered mortgage when the Resort was sold, by paying the Co-Owner Share to the Co-Owner. Where the Fractional Interest held by the Co-Owner was subject to a registered mortgage when the Resort was sold, by giving notice in writing to each such Co-Owner and each such mortgagee of the amount of the Co-Owner's Share and, thereafter, by paying that Co-Owner's Share as directed in writing by the Co-Owner and the mortgagee or as ordered by any court.

- 12. Stegbar were included as a respondent to the proceeding because, at the time of filing, a caveat lodged by Stegbar on or about 10 July 2013 against the interest of Steven Christofidellis in Lot 42 of the scheme (Stegbar Caveat).
- 13. Requests for the removal of the Stegbar Caveat and one other caveat also over Lot 42 by a deregistered company were lodged with the titles office on 10 November 2021. Appearing at [36] is a copy of the lodgement summary in respect of the two requests for removal.
- 14. The two caveats were removed from the title for Lot 42 on 22 November 2021. A copy of the Registration Confirmation Statement received by Mahoneys that day appears at [37].
- 15. Stegbar does not hold any other interest in the Company.

XYZ

- 16. Prior to commencing the proceedings, on 11 November 2021, I caused correspondence to be sent to XYZ:
 - (a) informing them that:
 - Oniska Pty Ltd (as XYZ was then known) held a registered mortgage over certain interests in certain lots of the Voyager Resort;
 - (ii) a search of the mortgage indicated that the mortgage had been released in respect of the majority of lots, but that it remained registered over 5 titles;
 - (iii) based on the age of the mortgage, we assumed that no monies remained outstanding by any of the mortgagors;
 - (b) providing them with:
 - (i) a copy of the mortgage; and
 - (ii) a release of mortgage form for execution by XYZ; and
 - (c) requesting that:
 - they execute and return the release of mortgage if they accepted that no funds remained outstanding; or
 - (ii) otherwise, they inform us if they said any money remained outstanding to XYZ which was secured by the Mortgage.

- 17. Appearing at [38] is an historical company search of XYZ.
- 18. Appearing at [43] is a copy of the correspondence.
- 19. On 1 December 2021 I received an executed copy of the release of mortgage form from XYZ. Appearing at [45] is a copy of the release.
- 20. Also on 1 December 2021, I caused a copy of the release to be filed in the titles registry.
- 21. On 3 December 2021 Mahoneys received a requisition in respect of the release, on the basis that the name of the Mortgagee had changed since the mortgage was first lodged. A copy of the requisition appears at [46].
- 22. On 7 December 2021 the amended release was re-lodged, along with an historical company search. A copy of the amended release (as filed) appears at [47].

Printing costs

- The originating application and affidavits in support of it (of Mr Heaton, Ms Julian-Armitage and Mr Hellen) filed by the applicant run to 2,508 pages (Material).
- The bulk of the volume of the Material is the affidavit of Mr Heaton, which alone accounts for 2,383 pages.
- 25. On 25 November 2021 I requested a quote from Law In Order, a printing and legal administration firm that Mahoneys regularly engages for the production of briefs and court books, for the production of 98 copies of the Material.
- 26. Appearing at [49] is a copy of the quote received from Law In Order, which is for \$27,916.24.
- 27. Additionally, the appellant has already incurred costs of \$13,776.29 for producing 54 copies of the Material. Appearing at [50] is an invoice from Law in Order for producing the original 54 copies of Material.
- 28. The total cost of printing the Material for service on the Respondent Members, ANZ, ASIC and XYZ would therefore amount to \$41,692.53.
- 29. If copies of the Material were to be provided in hard copy to every respondent, using the quote mentioned in paragraph 26 as a guide, the printing cost would be circa \$303,375.46.

Personal service

- Mahoneys typically engages Craig Lindley, a licensed commercial agent and principal of SmartServ Group ACN 763 158 074 to serve documents when required.
- 31. Based on discussions I have had with Mr Lindley, and matters in which I have previous engaged him I believe that:

- (a) the estimated cost of serving an individual (assuming three attempts, in South East Queensland, at normal priority and without any unusual service difficulties) is \$99 inclusive of GST per person;
- (b) the cost of service on people located outside South East Queensland may be higher;

- 34. On 29 November 2021, I placed one copy of the originating application and a draft covering letter on to the pre-paid post franking machine in my office and calculated postage based on a non-priority rate, which is the least expensive rate available. The price for sending just the originating application by ordinary pre-paid post was:
 - (a) \$5.45 for postage within Australia;
 - (b) \$20.02 for postage to New Zealand;
 - (c) \$24.09 for postage within the Asia-Pacific region excluding Australia and New Zealand;
 - (d) \$26.40 for postage to the United States; and
 - (e) \$32.34 for postage to the United Kingdom and Europe.
- 35. Applying the above rates, the cost of sending the Originating Application only to each of the Respondent Members by ordinary post would be \$1,147.67.
- 36. The entire bundle of Material, when printed double-sided, weighs around 6 kilograms.
- 37. On 26 November 2021 I caused a quote to be obtained from Pack & Send for the cost of couriering the Material to each of the Respondent Members, ASIC, ANZ and Stegbar.
- 38. The quote, which was based on:
 - (a) collection from Mahoneys' office;
 - (b) secure packing;
 - (c) generation of bar codes for tracking; and
 - (d) road express domestic and international courier movements to all 151 recipients,

was \$13,968.00.


