

I, Benjamin Leigh Sandford of Level 18, 167 Eagle Street, Brisbane in the State of Queensland, Solicitor, solemnly and sincerely affirm and declare:

1. I am a solicitor employed by Mahoneys, solicitors for the Liquidators of Voyager Resort Limited ACN 010 547 618 (**Liquidators and Company**).
2. I was admitted to practice in 2014 and since that time have practised exclusively in commercial litigation.
3. In addition to now acting for the Liquidators:
  - (a) Mahoneys previously acted for the Company in pursuing an application for the appointment of statutory trustees (**Trustees**) for sale of the resort property owned by it, which orders were made by Justice Ryan of the Supreme Court of Queensland on 22 March 2022 (**Trustee Orders**); and
  - (b) I had carriage of that matter (**Trustee Proceedings**) subject to the supervision of my principal.

### The Company

4. The Company was incorporated in 1984. From about the time of its incorporation until 2023 it was the operator of a 16-storey building containing 62 time-share lots located on the Gold Coast in Queensland named "Voyager Resort".
5. A historical company extract from the records of the Australian Securities and Investments Commission (**ASIC**) dated 24 July 2024 appears at BLS-1.
6. The Company operated Voyager Resort using a "time-share" model and owned two of the 62 strata titled lots in Voyager Resort from which it operated an office and residence for the on-site manager.
7. The remaining 60 lots in Voyager Resort were divided into 51 equal shares that were owned by investors. The shares took the form of a share issued by the Company and stabled to a proportionate interest in fee simple in the freehold title of the lot.

8. A share in the company entitled its owner, subject to payment of levies, to:

- (a) occupy a lot for one week a year;
- (b) hold a corresponding share in the Company; and
- (c) a proportionate ownership share in the freehold title of a relevant lot.

### **Trustee Proceedings**

- 9. There were 1065 respondents to the Trustee Proceeding.
- 10. In the course of preparing for the hearing of the originating application in the Trustee Proceedings, Mahoneys was provided with a register of the members of the Company by the secretary of the Company, Geoffrey Heaton.
- 11. Appearing at BLS-2 is a copy of the orders made in respect of substituted service in the Trustee Proceedings.
- 12. Appearing at BLS-3 is a copy of the Trustee Orders.

### **Liquidators contact with Shareholders**

- 13. The Liquidators were appointed by order of Justice Freeburn dated 2 May 2023. Appearing at BLS-4 is a copy of the orders appointing the Liquidators.
- 14. I am instructed by the Liquidators and believe that:
  - (a) in addition to being appointed as the liquidators of the Company, their firm, Pilot Chartered Accountants (**Pilot**), had been engaged by the Trustees to assist them in making the distributions they were obliged to make pursuant to the Trustee Orders;
  - (b) they caused Pilot to post correspondence to:
    - (i) the last known address of each person believed to be a member of the Company based on the records of the Company; and
    - (ii) attempted to contact the members by telephone at the last known telephone number for them, based on the records of the Company;

- (c) there are 59 members of the Company who have neither an email address nor postal address recorded in the records of the Company, being those members set out in the table that appears at annexure BLS-5; and
- (d) there are approximately 231 instances where the Liquidators propose to (subject to first complying with their obligations under the *Corporations Act* and *Corporations Regulation* with respect to the payment of dividends) pay the entitlement of a member of the Company to someone other than that member, due to the liquidator's forming the opinion that:
  - (i) ASIC is entitled to receive any distribution payable on the basis that:
    - (A) those members have not submitted a claim to the Liquidators (and therefore the Liquidators do not have confirmation about where any dividend payment ought to be made and any dividend ought to be treated as unclaimed monies); or
    - (B) the members are deregistered companies;
  - (ii) the member owes an amount to the Company that exceeds the amount of any potential distribution that the member would receive; or
  - (iii) the member recorded in the books and records of the Company should not be entitled to receive a payment because they were not, at the time that Trustees were appointed, the owner of a fractional interest (or otherwise, entitled to become the owner of a fractional interest) in a lot in Voyager Resort.

#### **Proposed cover letter**

15. In the event that the Court makes an order in accordance with those interim orders sought by the Liquidators' in the originating process, I am instructed by the Liquidators that they intend to give notice of the proceeding to the members of the Company by:
- (a) sending correspondence in the form annexed to this affidavit at annexure BLS-6 to the email and postal addresses that the Liquidators hold for the members of the Company;
  - (b) causing to be published in a newspaper having national circulation an advertisement in the form annexed to this affidavit at annexure BLS-7; and
  - (c) notifying ASIC of the proceeding.
