**THE COURT ORDERS THAT:**

**Advice under s 90-15**

1. Pursuant to s 90-15 of Schedule 2 of the *Corporations Act 2001 (IPS)*, the plaintiffs are justified in paying the dividend in respect of the share(s) stapled to a fractional interest:
  - (a) identified by the title reference in column B of the **Annexure** to this order; and
  - (b) recorded by the Queensland Registrar of Titles as being owned by the person identified in column D of the Annexure,to the person identified in column G of the Annexure (**Payee**) in respect of the number of shares in the Voyager Resort Ltd (in liq) (**Company**) identified in column C of the Annexure (**Shares**).
2. Pursuant to s 90-15 of IPS, the plaintiffs are justified in:
  - (a) setting-off against any dividend payable to a Payee such amounts recorded in column F (**Set-Off**);
  - (b) paying a first and final dividend, after complying with the formal requirements for dividends under the *Corporations Act 2001* and *Corporations Regulations 2001*, to the Payees as follows:



- i. first, a distribution to all Payees proportional with the number of Shares held by them, less any Set-Off (**First Round Distribution**);
  - ii. second, a distribution to those Payees who received a First Round Distribution, less any Set Off (**Second Round Distribution**);
- (c) taking no further recovery action against such Payees as did not receive a Second Round Distribution in respect of any Set-Off which remains payable by them; and
- (d) forgiving any Set-Off which remains payable following the Second Round Distribution.

### **Remuneration**

3. Pursuant to s 60-10 of the IPS, Bradley Vincent Hellen and Nigel Markey's remuneration for work performed in the course of the liquidation of the Company is approved at the hourly rates set out in the Affidavit of Bradley Vincent Hellen dated 24 April 2025 at exhibit BVH- 170, p 208, up to a limit of \$128,238 (exclusive of GST) .
4. The remuneration approved under order 3 is in addition to the remuneration approved by creditors on 27 July 2024 of \$795,095.75 (exclusive of GST).

### **Other orders**

5. The plaintiffs' costs of this proceeding are costs and expenses in the winding up of the Company.
